

Dear Parents,

The staff at Mahoosuc Kids Summer Adventure Program is looking forward to having your child join us this summer. The following is a list of items your child will need to bring each day that they attend the program.

- Back pack
- All meals, snacks, and beverages are program provided.
- **Water bottle. This is a must at all times!**
- Modest Bathing suit and towel
- Insect repellent and sunscreen
- Closed toed shoes, preferably sneakers, for hiking and games daily
- Closed toed water shoes for all swimming activities
- Rain gear, we go out in the light rain
- Sweatshirt, especially on chilly swim days
- Dry change of clothes

**PLEASE mark all belongings.** Personal toys and unnecessary belongings do not need to come to the program. We do not want to have sad troopers over lost or broken belongings.

Check in each morning will be held in the cafeteria at Crescent Park School (MKA's Base location). Check in will not be allowed before 8:45 AM unless your child is attending the early care program. Early care is \$5.00 per child and extended care is \$5.00 per child for each day used. Pick up will be in the cafeteria until 4 PM. If your child is staying for the extended care program you will pick them up down in the MKA room by using the side door of the building.

For safety and liability reasons, every child **must** be signed in and out by an adult, parent or guardian. NO EXCEPTIONS!

Field Trips are held on Wednesday's. We will have information available about the weekly field trip each Monday. Please make sure your read the field trip material so that your child will be prepared for the busy day. When you sign the contract and other important information, we will consider that your signature for Field Trip permission unless you otherwise specify. We will allow Game Boys or personal music players with head phones on field trip days **only**, at the child's own risk!

Please take the time to fill out the enclosed medical and liability form and return to Mahoosuc Kids at Crescent Park School, along with the first week's payment, as soon as possible.

The MKA Summer Adventure Program serves children entering Kindergarten through grade six who are from or visiting the greater Bethel/ MSAD # 44 area.

Fee Schedule:

***All fees must be paid in advance, on or before the first day each week in order to receive the reserved rate fee of \$30.00 per day.***

Non-reserved slots, based on availability, may be issued by MKA staff at the drop in rate of \$35.00 per day.

All reservations for undetermined days of care must be made 24 hours in advance of the day needed in order to be considered reserved. Payment must be made on the day of care to receive reserved rate if granted.

Absences are not refunded. Absences due to illness or family emergency may be credited if approved by the MKA director.

Invoices for SAP fees are only generated on delinquent accounts. All unpaid accounts fall delinquent at the end of the first unpaid week and children may not return to the program until a payment arrangement has been reached with the MKA director.

Scholarships may be available based on need. Contact the MKA Director for details.

Early childcare is offered from 7:30 AM until the program begins at 8:45 AM. Early care is held in the MKA room in the K-1 wing at the rate of \$5.00 per child per day.

Extended childcare is offered from 4:00 PM until 5:30 PM and is also held in the MKA room in the K-1 wing. The daily rate for extended care is \$5.00 per child per day.

If a child is picked up after closing time (5:30 PM), parents will be charged \$5.00 for each 15 minute interval or part thereof. Repeated late pick-up may result in a child's dismissal to the program.

Pursuant to contract between MSAD # 44 and Mahoosuc Kids Association by which MKA has permission to use MSAD #44 facilities, all participants in the MKA programs including the Summer Adventure Program must follow the MSAD #44 Code of Conduct, a copy of which is available upon request.
